

- To meet traveling boarding and lodging expenses for students going abroad for higher education . - To do any other act / acts which is decided by the board of trustees for the benefit of general public.
- To promote assist and/or maintain all activities by whatsoever carried on or wherever carried on in conformity with the objects of the trust and as conductive to the well being and general welfare of humanity or are conducive for advancement of any object or objects of the general public utility not involving/carrying on for profit

- m. If any one or more of the objects specified in clauses (3) of these presents are held not to be objects of the public charitable nature, the trustees shall not carry out such objects as if the same are not incorporated in these present but validity of trust created by these presents as a trust for public charitable purpose shall not be affected in any manner
- n. The financial of the trust shall end on the 31st day of March every year provided not contrary to the rules of government
- o. The trustees may accept any donation or contribution or loan from Body Corporate & Business Enterprises in cash or kind irrespective of cast, color, creed, bodies (Govt. or Non Govt.) for the furtherance of objects of the Trust for nay one or more of them upon such terms and conditions as they may in their absolute discretion think fit and which are not inconsistent with the objects of the trust. The trustees may take over the management of any other charitable or public institutions on such terms as they think fit and may manage such institutions.
- p. Without affecting the generality of powers and functions of the Trustees to manage and administer the trust, the board of the trustees shall have the following functions
- 1. To borrow if needed be against the security of the assets of the trust by the way of banks overdrafts, loans or otherwise, as may be necessary, for the benefit of the trust.
- 2. To collect funds in the form of donation to attain the object of the trust.
- 3. To arrange for and/or authorize the signing or execution of contract, instrument, document or any other paper or writing required to be signed or executed on behalf of the trustees and to make the same effective and binding as if the said agreement contract instrument and document or paper or writing were signed by all the trustees
- 4. To appoint or make provision for the appointment of Sub committee of trustees and/or others to attend or supervise or conduct specified jobs or functions or trust matters in such manner and subject to rules and regulations as the trustees may prescribe

- The trustees shall cause true and accurate accounts to be kept of all moneys received and spout of all matters in respect of there of in the course of management of the trust properties and affairs
- 6. If the income of the trust shall not fully utilize, the unexpended income subject to the applicable provisions of the Income Tax Act 1961. It shall be carried over to the next year or years for the advancement of any object of the trust
- 7. The trustees shall keep an account or accounts with any bank/banks to operate such account or accounts whether in debit or in credit and to give all appropriate instructions to the banker or bankers concerning the operation of such account or accounts and authorize by appropriate resolution. The operation of the bank shall be under the signature of Any two out of three persons i.e Chairman/Managing Trustee General Secretary and Treasurer
- The trustees may appoint Secretaries, Managers, Lawyers, Solicitors, Auditors, Architects, Engineers, Surveyors Gamastas or any other employee for the purpose of management of and the supervision of the trust and keeping the accounts and records and for the purpose of the trust
- 9. The board of trustees shall have the full power to compromise or compound all the actions, suits and other proceedings and settle differences and disputes touching the trust estate or properties and may refer any such differences or disputes to arbitration.
- 10. The trustees shall be entitled at their discretion from time-to-time start, discontinue abolish and re-start any charity or charitable institution, to impose any condition or conditions to any subscription or donation.
- The trustees may reimburse themselves and pay and discharge out of the Trust Fund.
- 12. All the trustees unless they voluntary resign, shall continue to be the trustees during the term of their natural life and later on their legal heirs (only sons) shall automatically become trustees.
- 13. Any trustee may retire at any time with the consent of trustees without assigning any reason or without being responsible for any costs occasioned by such retirement in the interest of the Trust to fulfill its objects.
